

# PhD in Humanistic Studies: Extraordinary Awards

## Criteria and Weightings

The criteria for prioritizing applications are based on tangible results achieved **during the completion of the thesis**, reflected in the following merits.

### A) SCIENTIFIC PRODUCTION RELATED TO THE THESIS (up to 50 points)

- **Publications in JCR and SJR indexed journals:** 15 points per publication
- **Publications in journals indexed in databases other than JCR and SJR:** 8 points per publication
- **Publications in non-indexed journals:** 5 points per publication
- **Book chapters in SPI-indexed publishers:** 8 points per publication
- **Book chapters in non-SPI-indexed publishers:** 5 points per publication
- **Publications in international conference proceedings:** 2 points per publication
- **Publications in national conference proceedings:** 1 point per publication

If the work is signed by multiple authors, the final score for the publication will be calculated by multiplying the assigned points by the corresponding coefficient based on the number of authors, as follows:

No. of authors	Coefficient
2	0.9
3	0.8
4	0.7
5	0.6
6 or more	0.5

**THESIS BY COMPENDIUM OF ARTICLES:** If the defended thesis is a compendium of articles, the final score for the included publications will be calculated by multiplying the assigned points by a coefficient of 0.5.

### B) OTHER MERITS (up to 50 points)

- **Competitive teaching staff training grants:** 15 points
- **Other grants (BIDI, project grants, collaboration grants...):** 5 points
- **Research stays at research centres:** 2 points per month
- **Participation in research projects:** 2 points per year
- **European or international mention or cotutelle:** 15 points
- **Presentations at international conferences:** 10 points per presentation
- **Presentations at national conferences:** 5 points per presentation
- **Science outreach activities:** 2 points per activity
- **International awards:** 3 points per award
- **National awards:** 2 points per award
- **Local or regional awards:** 1 point per award
- **University teaching:** courses up to 3 credits: 0.5 points; courses over 3 credits: 1 point

- **Training:** 0.5 points per course/seminar, up to a maximum of 5 points
- **Patents/Intellectual Property Protection:** 10 points per patent
- **University extension courses or other courses:** 0.5 points per course

 **THE MINIMUM SCORE TO BE ELIGIBLE FOR THE EXTRAORDINARY DOCTORAL AWARD IN THE HUMANISTIC STUDIES PROGRAM WILL BE 50 POINTS.**

 **TO OBTAIN THE EXTRAORDINARY AWARD, IT WILL BE A NECESSARY (THOUGH NOT SUFFICIENT) CONDITION TO ACHIEVE AT LEAST 30 POINTS IN SECTION A OF THE SCORING SYSTEM.**

## **REQUIRED SUPPORTING DOCUMENTATION**

Applications must be accompanied by a ***curriculum vitae*** (using the template provided) that specifies the candidates' qualifications according to these criteria (template attached) and the documentation submitted must be contrasted and ordered according to the criteria and weightings established by the Academic Committee of the Doctoral Program in Humanistic Studies.

All documents referring to scientific production and/or merits that are claimed must be referenced with a section and subsection of the criteria and weightings.
